## CHANGE OF OWNERSHIP

If a change of ownership occurs, the registered owner and the new owner must notify the Council in writing within 14 days. Failure to do so carries a fine of 1 penalty unit.

## CHANGE IN OTHER REGISTRATION DETAILS

The Act requires that any changes in the particulars shown above for the dog(s) to be notified to the Council in writing or by completing and signing this form.

## REGISTRATION AGE

The owner of an unregistered dog that is over the age of 6 months is guilty of an offence and is liable for prosecution in accordance with the provisions of the Dog Control Act, 2000.

- No refunds given for transfer to other Local Government Areas.
